

# M.O.B.I.L.E PROGRAM FACILITATOR ( Contracted Summer 2024 )

**Movement Education Outdoors** (MEO) empowers Black, brown, and low-income youth in Rhode Island through outdoor education. Our mission is to create a space where young people of color feel seen, valued, and equipped to lead in their communities. MEO values mindfulness, community, belonging, equity, transparency, and collaboration.

This contracted role will support the M.O.B.I.L.E program at MEO. The role will be responsible for crafting inclusive, immersive outdoor education experiences and co-leading programs that blend hands-on exploration, diverse themes, and cultural sensitivity. The role will actively guide participants through curriculum-rich activities and discussions.

**About the Program:** MOBILE (Mindful Outdoors Black & Indigenous Leadership in the Environment) began in 2021 as a hiking and kayaking program for BIPOC high school students. Through deep engagement with one "theme," Fellows will explore the intersections between coastal science, Black & Indigenous history, and food & environmental justice in Rhode Island.

# **Essential Skills**

The ideal candidate is passionate about MEO's mission to empower Black, brown, and low-income youth in Rhode Island through outdoor education. To succeed in this role, candidates must have:

- Outdoor educator skills: Experience delivering hands-on, culturally relevant programs.
- Strong water safety skills and ability to implement safety protocols.
- Ability to effectively communicate and collaborate with staff, youth, and caregivers.
- Ability to proactively plan, thoughtfully problem-solve, and manage situations.
- Proactive, detail-oriented, and proficient with Google Suite.
- Ability to collaborate effectively in a small team environment.
- Driver's license and car required.
- Wilderness training is preferred.

# Qualifications

This seasonal position would be ideal for someone with a demonstrated interest in environmental justice, outdoor education, and programming. Ideal prior experience would include:

- Prior experience leading and facilitating outdoor education programs.
- Strong leadership and service skills, especially in an instructor role.
- Candidates should be comfortable and enjoy interacting with young people.
- Demonstrated ability to work independently on assigned tasks and collaboratively with others.

#### **Working Conditions**

- This position is an onsite role. MEO programming provides seasonal programs at a few locations. Summer programming will take place Monday through Friday. Due to the programming calendar's seasonality, many employees work more of their time in person.
- Exempt employees are asked to work a flexible schedule as determined by the volume of work; however, the organization works hard to ensure proper work-life balance and to prevent burnout.

The physical requirements of this role listed below are representative of those that may need to be met by an employee in this role:

- Ability to work outdoors in various weather conditions.
- Standing, walking, and bending for extended periods.
- Be prepared to navigate different walking surfaces in the outdoors.
- Carrying and using personal protective equipment (PPE) as necessary may include items like hats, hiking boots, or personal flotation devices (PFD).
- The job may require working on uneven surfaces or in awkward positions.
- Occasionally lifting up to 20 pounds; however, assistance with lifting or moving items can be provided.
